Proposals should affect properties on or within 10 miles from Route 66, unless an exception is made by the Historic Preservation Board. Any projects not directly on Route 66 will have to provide evidence of the impact the applicant's property had on the history of Route 66.

Monies must be utilized for the project applied for. Upon completion of the project, Applicant must provide pictures and documentation evidencing completion of the project and how the monies donated were utilized.

Applicants consent to pictures of the project being published in Show Me Route 66 Magazine of the applicant and of the completed project.

The Route 66 Association of Missouri is in no way responsible for the project, the property upon which the project is situated, for any injury or damage caused upon the project property or for a rejection of your application.
